AN ORDINANCE temporarily repealing Chapter \$2.12 of the Tonasket Municipal Code entitled "Police Department" and providing for police services to be temporarily provided by contract and designating the Sheriff of Okanogan County to be the Chief Law Enforcement Officer for the City of Tonasket until the Tonasket Police Department can be re-established.

THE CITY COUNCIL OF THE CITY OF TONASKET, WASHINGTON, DO ORDAIN as follows:

- **Section 1.** Section 2.12.010 providing as follows: "A department, to be hereafter known as the Tonasket Police Department, is created, the purpose of which is to provide for law enforcement in the City," together with the entirety of Chapter 2.12 entitled "Police Department," is hereby repealed.
- **Section 2.** Law enforcement within the City of Tonasket shall temporarily be provided by contract with the Okanogan County Sheriff's Office.
- Section 3. In compliance with RCW 35A.12.020, the duly elected Okanogan County Sheriff shall be temporarily designated the Chief Law Enforcement Officer for the City until the Tonasket Police Department is re-established.
- **Section 4**. This ordinance shall become effective from and after its passage by the council, approval by the Mayor, and publication as required by law or, the effective date of a contract and/or an Interlocal Agreement between the City of Tonasket and the Okanogan County Sheriff's Office to provide law enforcement within the City of Tonasket, whichever is later.



### PROFESSIONAL SERVICES AGREEMENT

THIS AGREEMENT is made and entered into this 8th day of March 2019, by and between the City of Tonasket, a Washington municipal corporation, hereinafter referred to as the "City", and Sob Consulting hereinafter referred to as the "Service Provider".

#### RECITALS

Whereas, the City desires to have certain services and/or tasks performed as set forth below requiring specialized skills and other supportive capabilities; and

Whereas, sufficient City resources are not available to provide such services; and

Whereas, the Service Provider represents that the Service Provider is qualified and possesses sufficient skills and the necessary capabilities, including technical and professional expertise where required, to perform the services and/or tasks set forth in this Agreement,

Now, therefore, in consideration of the terms, conditions, covenants, and performance contained herein,

## The parties hereto agree as follows:

- 1. Scope of Services. The Service Provider shall perform such services and accomplish such tasks as are identified and designated in Exhibit A attached hereto and incorporated herein as though fully set forth.
- 2. Term. The project is expected to be a 3 month project which shall begin on March, 18, 2019 and may be terminated or extended as set forth in paragraph 6.
- 3. Compensation and Method of Payment. Payment for services provided hereunder shall be made following the performance of such services. City shall pay the Service Provider for work performed under this Agreement at the rate of \$10,000,00 a Month for work performed. Service Provider shall keep track of all hours performed under this Agreement and submit those hours for review and payment by the City.
- 4. Independent Contractor Relationship.
- 4.1 In the performance of the services herein contemplated the Service Provider is an independent contractor with the authority to control and direct the performance of the details of the work, however, the results of the work contemplated

herein must meet the approval of the City and shall be subject to the City's general rights of inspection and review to secure the satisfactory completion thereof.

4.2 The City is interested primarily in the results to be achieved. The implementation of services will lie solely with the discretion of the Service Provider. The Service Provider shall not be deemed to be an employee.

#### 5. Hold Harmless Indemnification.

- 5.1 Service Provider shall defend, indemnify and hold the City, its officers, officials, employees and volunteers harmless from any and all claims, injuries, damages, losses or suits, including attorney fees, arising out of or resulting from the acts, errors or omissions of the Service Provider in performance of this Agreement, except for injuries and damages caused by the sole negligence of the City.
- 5.2 No liability shall attach to the City by reason of entering into this Agreement except as expressly provided herein.
- 5.3 Contractor shall not be liable for any work product uncompleted in the event of early termination pursuant to Para 8.2.

## 6. Compliance With Laws.

- 6.1 The Service Provider, in the performance of this Agreement, shall comply with all applicable federal, state or local laws and ordinances, including regulations for licensing, certification and operation of facilities, programs and accreditation, and licensing of individuals, and any other standards or criteria as described in this Agreement, to assure quality of services.
- 6.2 The Service Provider specifically agrees to pay in the end all taxes and assessments that may be due on account of this Agreement.
- 7. Changes. Either party may request changes to the scope of service to be provided hereunder, however, no change or addition to this Agreement shall be valid or binding upon either party unless such change or addition be in writing and signed by both parties. Such amendments shall be attached to and made part of this Agreement.

#### 8. Extension and/or Termination.

- 8.1 This Agreement may be extended by mutual written consent of both parties.
- 8.2 <u>Termination of Convenience</u>. The City may terminate this Agreement, in whole or in part at any time by giving seven (7) days written notice to the Service Provider.

- 8.3 <u>Termination for Cause</u>. If the Service Provider fails to perform in the manner called for in this Agreement, or if the Service Provider fails to comply with any other provisions of this Agreement and fails to correct such noncompliance within five (5) days written notice thereof, the City may terminate this Agreement for cause. Termination shall be effected by serving a notice of termination on the Service Provider setting forth the manner in which the Service Provider is in default.
- 9. Attorney Fees and Costs. If any legal proceeding is brought for the enforcement of this Agreement, or because of a dispute, breach, default or misrepresentation in connection with any of the provisions of this Agreement, the prevailing party shall be entitled to recover from the other party, in addition to any other relief to which such party may be entitled, reasonable attorney's fees and other costs incurred in such action or proceeding.

#### 10. Jurisdiction and Venue.

- 10.1 This Agreement has been and shall be construed as having been made and delivered within the State of Washington, and it is agreed by each party hereto that this Agreement shall be governed by laws of the State of Washington, both as to interpretation and performance.
- 10.2 Any action of law, suit in equity, or judicial proceeding for the enforcement of this Agreement or any provisions thereof shall be instituted and maintained only in a court of competent jurisdiction in Okanogan County.

## 11. Severability.

- 11.1 If for any reason any part, term or provision of this Agreement is held by a court of the United States to be illegal, void or unenforceable, the validity of the remaining provisions shall not be affected, and the rights of the parties shall be construed and enforced as if the Agreement did not contain the particular provision held to be invalid.
- 11.2 If it should appear that any provision hereof is in conflict with any statutory provision of the State of Washington, said provision that may conflict therewith shall be deemed inoperative and null and void insofar as it may be in conflict therewith, and shall be deemed modified to conform to such statutory provisions.
- 12. Entire Agreement. The parties agree that this Agreement is the complete expression of the terms hereto and any oral representations or understandings not incorporated herein are excluded. Further, any modification of this Agreement shall be in writing and signed by both parties. Failure to comply with any of the provisions stated herein shall constitute material breach of performance of the provisions of this Agreement. It is also agreed by the parties that the forgiveness of the nonperformance

of any provision of this Agreement does not constitute a waiver of the provisions of this Agreement.


