Minutes of the Regular City Council Meeting Tuesday, December 10, 2019 **DRAFT**

Present: Mayor Brown and Councilmembers Kriner, Levine, Ritter and Sackman.

Staff: Attwood, D. Johnson and Miller

The meeting was called to order at 7:00 pm and the pledge of allegiance was given by all.

Roll call was done and all members were in attendance.

Motion to approve the agenda. M/Sackman, S/Levine. Carried 4:0.

<u>The Oath of Office was administered by City Clerk-Treasurer Attwood to newly elected Councilmember Weddle.</u>

Public Comment

Debbie Roberts-lives outside the City

Is concerned about the City not having a Code Enforcement position. She walks every
day on Western Ave. and would like to have the property with all the junk cars be taken
care of. She encourages the Mayor and Council to move forward with hiring a Code
Enforcer.

George Hill-City resident

• Clarified that the property Debbie Roberts commented on is his. It is zoned as a commercial zone and he doesn't have anyone living there.

<u>Trey Dail – T O Engineers Presentation.</u> Trey was present to update the Mayor and Council on the Airport Runway Project. In 2018 a grant was awarded for \$40,000 for the design of the project. WSDOT had no money for grants in 2019 but will be awarding \$500,000 for construction and the City would have a 5% match in 2020. He presented four options that the City could go with for the project:

- 1. Do an overlay on the existing runway costing \$400,000.
- 2. Pulverize the existing runway, lay 6" base course and repave costing \$450,000.
- 3. Pulverize the existing runway, lay 9" base course and repave costing \$520,000.
- 4. Do a full depth rehabilitation costing between \$700,000 and \$750,000.

The asphalt alone will cost approximately \$300,000. He recommends that the City go with Option 2 and approve going out for bid in January. The grant application is due by April 1st and will be awarded in early June. Construction could start in early August and will take approximately 3 weeks to complete.

Unfinished Business

<u>Resolution 2019-17.</u> Clerk Attwood explained the 2020 Fee Schedule and informed the Council that Attorney Howe had reviewed it and approved. There are increases to Water and Sewer and other small adjustments. Councilmember Levine asked about the Chief Tonasket Park Field Use Fee.

Motion to approve Resolution 2019-17, the 2020 Fee Schedule. M/Ritter, S/Kriner. Carried 4:1. Weddle abstained.

Park and Recreation Budget for 2020. Councilmember Levine questioned why at the bottom it says disbursements in excess of any line item budget require approval from the Tonasket Park and Recreation District Board. It was explained that if something is needed that goes over the budget amount, the City would need to ask the Park and Rec Board before purchasing. The Park and Rec would then decide if they could amend the budget or not. If they decide to not amend the budget then the City would have the option to close the pool if enough funds were not available to run it.

Motion to approve the Park and Recreation Budget for 2020. M/Kriner, S/Sackman. Carried 5:0.

2020 Budget Ordinance #809. The Clerk briefly went over the 2020 budget. She explained the only Hotel/Motel request she hasn't received is from the Rodeo Club. The Drug Fund was not included because it was never used. The budget total is \$3,942,078.70.

Motion to approve the 2020 Budget Ordinance #809 and attachments... M/Kriner, S/Ritter. Carried 5:0.

Parry's Acres Status Report. Clerk Attwood read a memo from Jeff Moran with Varela & Associates concerning the closeout process being stalled due to Award Construction's subcontractor, Advanced Power, failure to submit their affidavit of wages paid. There has been an issue with the emergency power generator. He asked the Council to authorize the Mayor and/or the Public Works Committee members to approve an amount not to exceed \$10,000 to resolve this issue before funding expires. After discussion it was decided to move this to the Water/Sewer Committee to discuss this further with Jeff and find out the time constraints. If needed a special meeting can be called by the Mayor to finalize it before the end of the year.

<u>Perfect Passage Master Plan Memo.</u> A memo from Jeff Moran, Varela and Associates, asked for feedback from the Council and Councilmember Ritter said that if they would get them to her or Councilmember Levine, they would share them with him.

Department Head Reports

Hawley:

- Presented the Sheriff's last 30 days report to the Council.
- Deputy Malone will be graduating on Friday and will then spend the next 10 weeks on FTO training before going on his own.

Happy New Year Everyone! I look forward to working with you in the New Year and a new decade.

The Oath of Office will be administered to Alisa Weddle and Jeff McMillan. It is appropriate for the Oath to be administered to Alisa again due to the fact that she was filling in the vacant position and will now be filling the position she was elected to.

This meeting has been advertised as a public hearing to review the final project performance on the Parry's Acres Sewer System Rehabilitation Project and the SR 97 Perfect Passage Street Project. Both of these projects were funded with Community Development Block Grant Funds (CDBG) and this hearing is a requirement of that funding.

Ed Koonce, a Tonasket resident, is on the agenda to invite you to a Neighborhood Watch Program Public meeting and tell you about the program.

There is information in your packet regarding the status of the Parry's Acres Project from Varela and Associates. Councilmembers Ritter and Levine will be reporting on this matter. The generator issue needs to be resolved and the Change order and the final Pay Estimate approved. Will require action.

Also, the Perfect Passage Master Plan is ready for adoption---memo attached. Requires action.

I have included in the packet three quotes for the tree work in History Park. This work needs to take place so we can open the park in the spring. There is a potential liability problem if these trees are not taken care of and this is a great time to proceed. There is a possibility the quotes may not be honored due to the passage of time however this may not be the case if the company that is chosen is contacted. Requires action.

The addendum to the Professional Services Agreement for Steve Brown is on the agenda again due to the fact that Exhibit A items have changed. This document will require action.

Resolution 2020-01 is to renew Professional Services Agreement with Highlands Associates, this is an annual renewal. Requires action.

Resolution 2020-02 approves the City applying for application for USDA-Rd funds for the City Shop roof. Requires action.

Ordinance #811—this is a budget amendment to add a fifth position to the Public Works Department. Due to the fact that we have one of our Public Works Personnel on L & I and he may be having another surgery soon, the Department is short-handed and needs this person on staff. The reason for a budget amendment is that by hiring someone full time, it adds another full time position to the Public Works Department which is not included in the budget.

The budget amendment states that the fifth position will end, and that is due to the fact that the Assistant Superintendent will be retiring in the spring and that will bring the Public Works Department back to a 4 person department.

Requires action.

According to the council rules adopted 11-12-2019 #5, page 4, "The Mayor Pro Tempore shall be elected by a majority vote of the Council from its own membership at the first meeting or a meeting soon thereafter after each general election and thereafter at such times as a vacancy occurs." This will require a vote of the Council for a Mayor Pro Tem.

Pay Estimate No.6 (Final)

Mayor and City Council,

Please see attached Change Order No.4 in the amount of \$3,975 and Pay Estimate No.6 (final) in the amount of \$4,102.20 (including tax and retainage). This is presented to the City to resolve the ongoing issue with the emergency standby generator installed at Lift Station No.2. It is our recommendation the City approve and sign the attached Change Order and Pay Estimate.

ISSUE

Please review the December 5, 2019 Status Report memo which describes the issue in detail (attached). This issue has also been discussed with the Public Works Committee.

We have had several discussions with the Contractor and have negotiated an agreement which, in our opinion, provides the most expeditious solution to the issue for the lowest cost to the City. This solution will avoid additional engineering costs, project administration costs and potential legal costs which could easily exceed the negotiated amount.

The proposed solution is to install VFD starters on the pump station motors to reduce the starting loads and allow the installed generator to start the pump and operate as intended. It has also been agreed to split the cost for the equipment and installation.

CHANGE ORDER NO.4

Change Order No.4 (CO4) authorizes the installation of two VFDs (one for each pump) to replace the existing pump starters. This change order represents half the cost of the equipment and installation.

With authorization of the CO4 the contractor will order the parts and schedule the installation which is estimated at 3-4 weeks lead time and 1-2 days' field work.

PAY ESTIMATE NO.6 (FINAL)

Approval of Pay Estimate No.6 authorizes payment for Change Order No.4. This is the final pay estimate and will conclude the contract. Upon installation of the equipment authorized in CO4 the contract will be complete and we can complete the project close out process.

BUDGET IMPACT

The original bid for the construction of this project was \$899,899.40. With approval of the attached change order the final cost for the project will be \$901,910.94, which is less than 0.5% above the original bid price.

Mayor and City Council,

This memo is to update you with the current status of the Parry's Acres Sewer System Rehabilitation project.

STATUS

The project is complete and the project closeout process has been started. The closeout process has been stalled due to one of Award Construction's subcontractors, Advanced Power, failure to submit their Affidavit of Wages Paid.

I believe their failure to submit this affidavit is related to an ongoing issue with the Lift Station No.2 standby emergency power generator.

ISSUE

The standby emergency power generator installed at Lift Station No.2 does not operate as required and has so far ben unable to start the pumps. This has not been an issue to date as there has not been a power failure.

We have been moving forward with project closeout and attempting to resolve the generator issue as a "warranty" issue but have so far been unable to resolve this issue as the Contractor is claiming the generator failure is not his responsibility and he will require additional compensation to correct the problem. We disagree with this and have been pushing for him to correct the problem and that no additional compensation will be forthcoming.

CLAIM

The Contractor is claiming he has supplied a generator meeting the specifications, has received an approved submittal to install the generator, and that the failure of the generator to start the pumps is due to inadequate sizing on the design engineers side.

While it is true the generator was approved through the submittal process the specifications require the installed generator to be sized by the generator manufacturer and meet certain performance requirements. As proved by the failure of the generator to start the pump the supplied and installed generator does not meet these performance requirements.

REMEDY

There are two potential solutions to this issue:

- 1. Replace the generator with a generator that meets the performance requirements
- 2. Install VFD's (variable frequency drives) on the pump starters to reduce the starting loads so the installed generator can start the pumps

It is my opinion the second solution will solve the problem and is cheaper and quicker to implement.

STATUS

We are currently attempting to schedule an in person meeting with Award Construction, their subcontractor Applied Power, AEI, our electrical sub consultant, and ourselves. It is our goal that this meeting result in a resolution to this issue. This meeting should happen within the next 5-10 days.

POTENTIAL OUTCOMES

While we strongly disagree with the Contractor's position and believe the contract to be very clear regarding the required performance of the generator and the failure of the installed generator to meet these requirements, we are also cognizant of the potential costs associated with continuing this course of action. It is our goal to find a solution that solves this issue at the least expense to the City. This may result in agreeing to some sort of cost share in the solution.

REQUEST TO THE MAYOR/COUNCIL

It is my understanding this is the final council meeting of the year. The funding for this project expires at the end of the month. We are working toward a resolution on this issue before the end of the year but are also considering requesting the Ecology funding be extended in case we are unable to come to a resolution.

Based on these constraints we are requesting the Council at the December 10th council meeting authorize the Mayor and/or the Public Works Committee members the authority to approve an amount not to exceed \$10,000 to resolve this issue so as to achieve resolution before the funding expires. This would not come from City funds but would be attached to the project funding.

Our position is to continue to push the contractor to correct this issue without additional project funds but continuing in this direction, especially if it moved into the legal realm, has the potential to result in unknown total costs to the project that could easily exceed this requested amount.






REASON FOR TREE WORK REQUEST

A risk assessment was done on many of the trees in History Park. 5 trees were deemed hazardous to the level that they need to be removed. Another 17 trees have large branches that could fail and harm people or damage property—some in the park, other properties adjacent to the park.

Attachment 1 below is a spreadsheet titled, *Tree Inventory/Condition Spreadsheet*. It lists the trees by the metal tag number on each tree, the DBH, that is, the trunk diameter at 4.5 feet above the ground, comment, a condition rating, and a recommendation—that is removal of 5 trees and pruning of 17 trees.

The City of Tonasket is requesting a proposal to remove the five trees and prune the additional 17 trees of their dead branches.


<u>Photo # 1</u>: A panoramic photo of the 19 Black Locust trees along the southern property line of History Park.



Three of the 19 trees need to be removed for safety. The other 16 trees need to have the dead wood pruned out.

In addition, there are two pine trees with significant internal decay and root rot that need to be removed. They are trees # 90 & 91.

Tree # 92 is an oak with multiple dead branches that need trimming.





- 1) As of January 1, 2020, the fifth position is created in the Public Works Department and will be paid \$15.50 per hour, with full benefits-medical, dental, vision and retirement for the employee and will be paid as depicted in the budget for the 4th position.
- 2) This position will end with the retirement of the current person in position number 2, the Assistant City Superintendent.

This ordinance shall become effective from and after its passage by the Council, approval by the Mayor and five days after publication as required by law.
